- 70. Declarations of interest: There were no declarations of interest.
- 71. Apologies for absence: Cllr Kim Franks and Mr Frank Campbell.

- 74. Planning applications: Members **RESOLVED** to make the following decisions.

22/00209/FUL: Construction of 9 no. single storey dwellings, creation of new vehicular and pedestrian access on to Monk's Hill including landscaping and associated works. Land west of Monks Hill, Westbourne. Members had **NO OBJECTION.**

22/02555/FUL: Demolition of existing building and erection of replacement dwelling following permission 20/01786/PA3Q. Little Hambrook Farm, Common Road, Hambrook. Members **OBJECTED** as it was considered to be contrary to countryside policy paragraphs 45 and 46.

22/02794/DOM: New front boundary wall and entrance alterations. Millthorpe, Monks Hill, Westbourne. Members had **NO OBJECTION** and would like to draw the local planning authority's attention to the comments made by WSCC Highways.

22/02796/DOM: Proposed Juliet balcony. Millthorpe, Monks Hill, Westbourne. Members had **NO OBJECTION** and would like to note that it appeared that the Juliet balcony had already been installed.

22/03010/DOM: Alterations to existing flint stone outbuilding to create ancillary annexe, including alterations to fenestration and cladding, installation of a wood burner and 2 no. velux windows to southern elevation. Installation of UV Solar panels on roof of Coach house to southern elevation. Weston Cottage, Woodmancote Lane, Woodmancote. Members had **NO OBJECTION** providing a condition was included

limiting the occupation to ancillary use of the main dwelling and preventing the permanent establishment of a separate dwelling.

22/02767/TCA: Notification of intention to prune back crown, height and width to boundary by 2m on south west sector on 1 no. Yew tree (quoted as T1). Little Stacks, Whitechimney Row, Westbourne. Members had **NO OBJECTION.**

SDNP/22/05024/HOUS: Erection of part single and two-storey extension to replace glazed extension along the south-east elevation. Removal of part of the extended first floor mezzanine area. Establish a basement to the north-western end of the house. Replace existing dormer with 2 no. new dormers to the south-east elevation. Reduce size of existing first floor balcony. Various alterations including changes to fenestration with relocation of entrance from the south-east elevation to the north-east elevation. Demolish existing garage and replace with new double garage/storage with annexe above. New entrance gates and landscaping including new patio. The Great Hall, Sheepwash Lane, Aldsworth. Members had **NO OBJECTION** provided that the design was in keeping with the arts and crafts building.
