19/02404/ADV: 1 no. illuminated fascia sign (A), 1 no. double sided illuminated hanging sign (B), 1 no. amenity board (C), 1 no. chalk board (D), 1 no. A2 lockable poster case (E) and 4 no. new lanterns (G). Stags Head, The Square, Westbourne. No objection.

19/02406/LBC: Erection of illuminated and non-illuminated signs to exterior of the building. Stags Head, The Square, Westbourne. No objection.

SDNP/19/04595/FUL: Replacement building for use in connection with the keeping of horses. Aldsworth Stud, Sheepwash Lane, Aldsworth. No objection.

SDNP/19/03858/FUL: Temporary rural worker's dwelling/mobile home for a period of 3 years (restrospective). The Piggery, Aldsworth Common Road, Aldsworth.
