Westbourne Parish – March 2025

Action proposed

- 1. Two new Community Highways Scheme (CHS) applications (S and centre) to improve road safety by 31 July 2025.
- 2. ReviewTRO plans and impement in priority order and also monitor existing TRO applications

WSCC planned council devolution

With Sarah Sharpe I have raised questions at WSCC about the importance of continuing with the CDC Local Plan wildlife corridors and the funding of the Wildlife Officer for the next five years from developer CIL contributions.

Public consultation

Government is running a consultation on views on WSCC / ESCC / Brighton and Hove devolution until Sun 13th April.

Government Ministers will need to decide:

- A. Whether they consider that the establishment of a Combined County Authority in the area is likely to improve the economic, social and environmental wellbeing of some or all of the people who live or work in the area;
- B. Whether establishing a Combined County Authority in the area is appropriate, having regard to the need to:
 - i. secure effective and convenient local government; and,
 - ii. reflect the identities and interests of local communities.

Without any information from Government on any structures, what happens to all of the Borough and District Councils within Sussex, whether Police are included and how many Single Councillors there might be to represent everyone, it's obviously difficult to answer, but Parishes and residents ARE urged to put their views forward.

In looking at the pros and cons of devolution Parishes and residents might want to consider:

- 1. Is the timescale of just one year to vote in a new mayor and sort out all of the Sussex area structure and services too short (it likely is)
- 2. Will there be better or worse representation of resident needs at local and Mayor level?
- 3. Will the new Authority provide an opportunity for your local community to benefit more?
- 4. Do you think resident service RANGE of services will get better or worse? (no evidence either way currently)
- 5. Do you think that resident service QUALITY of services will get better or worse?
- 6. Do you think a combined authority will help INNOVATION e.g. better buying power for a hydrogen bus fleet?
- 7. Do you think the overall COST of the services offered across Sussex will go up or down (some Mayor areas have worked well with greater cash efficiencies, others have gone bust)
- 8. Effects on new housing (the new Mayoral Sussex area will have overall control of where new housing goes)
- 9. Effects on the environment and sewage
- 10. Effects on the economy and jobs

2025 secondary school new admissions

As last year, in 2025 WSCC has offered a school place requested by parents for every child in West Sussex.

Bourne Community College this year has 180 places and 174 of those have been filled, leaving 6 vacancies. Official announcements to parents go out 3rd March.

Westbourne road safety plans 2025

We have a meeting with Mike Dare, WSCC Highways Engineer on Tue 4th March at 9:00 to 12:30. Jane Gould will be on CHS W1 group and Roy Briscoe will be on CHS W2 group. There was also a pre-meeting 17/2. The plan is for Westbourne Parish to apply for two CHSs by end of July 2025. These will combine several TROs planned as follows:

- 1. **CHS W1:** Parking improvements in The Square includes pavement triangle and planter outside the Window Box, to avoid parking blocking The Square near Coop. Parking restrictions and one way system past the Coop. One way signs into The Square by Lamb buildings. Includes new Pavement bollards end Whitechimney Row, widen pavement and bollards near Spice Cottage, add pavement section near bin outside surgery.
- CHS W2A: Woodmancote speed reductions South Lane 30mph from 40mph, end Woodmancote Lane 30mph and Woodmancote village 20 mph zone plus signage Includes current TRO W3 20 mph in Woodmancote village, 40 to 30mph Woodmancote Lane after Dell cottages
- CHS W2B: Old Farm Lane reduction NSL to 40mph, Whitechimney end 20mph plus TRO S11 Stein Road from South Lane NSL to 30 mph plus signage Includes current 3089548 and 3099396 (failed), TRO W4 (20mph Old Farm Lane into Whitechimney Row) Old Farm Lane NSL tp to 40 and TRO W6 (Square parking)

Westbourne CHS 1 – submission by 31 July 2025

We had some TRO failures, due to the WSCC system not scoring speed reductions particularly well versus other types like parking and lines, which is being addressed separately. The plan is therefore to apply for two CHSs by end of July 2025 to improve road safety and parking and reduce speeds. Working with WSCC, the Parish also then needs research the options decided on with local residents, with the aim of getting at least 70% approval on all options.

The Square Westbourne - parking improvements

- New pavement triangle and cone planter outside the Window Box, to avoid vehicles obstructing the highway near the Coop. Promote this with signs and crochet
- New line hatching on SW corner of Westbourne surgery to prevent parking too far N, add pavement section and move bin to allow pedestrians to pass more safely
- Coop: renew double yellow lines and single yellow lines outside the Coop and into King Street to prevent inconsiderate parking. Two wall notices (E & W) reminding customers not to park directly outside the Coop. Wall notice pointing out the Coop car park location and reminding customers not to block the car park entrance
- The Square North section (Lamb buildings). Options were put forward for a TRO in early 2024 to widen the pavement to four feet and put bollards along the edge to prevent parking on the slim pavement (one resident had her door blocked by a van when there was a fire in the house). The view was that, since the double lines were repainted that parking has been less of an issue, plus the Stags Head and Spice India would not be likely to support this measure based on previous responses
- Nigel to talk to Stags Head owner about any other possible parking improvements
- Consider adding disabled parking space in section of double yellow lines on the south side of the Square near the Westbourne Café (two others already at surgery)
- The view was East St CDC parking enforcement was difficult as many parking infringements are at weekends (Westbourne bakery) and after 5.50 (Spice Cottage)
- Parish to talk to Westbourne Bakery and Spice Cottage about signs that say 'have you parked considerately?' to avoid double yellow parking and blocking garage

Road safety improvements – central Westbourne

- Double yellow short section on North section of North Street (opposite new house and West of River Street)
- Junction of Edgell Road and Foxbury Lane No parking sign on pole to stop vans parking and obstructing traffic view of traffic coming South down Foxbury Lane
- Northbound only one way traffic past the Coop was considered but on balance it was decided that preventing inconsiderate parking was more important
- One way only sign to be reinstalled near Lamb Buildings on junction of North section of The Square

- Replace three grey Glasdon pavement bollards at the end of Whitechimney Row and junction of East Street to improve crossing safety
- Westbourne Road opposite St John's Church new old people crossing red warning triangle sign to get drivers to comply with 20mph limit

Westbourne CHS W2– speed reductions

Woodmancote Lane reduce speed to 20mph from 30mph.

- Reduce the speed limit from the current 30mph area to 20mph, there is no footpath and the road is very narrow in certain sections where 2 vehicles cannot pass, there is a pub along this section of Road so pedestrians and cyclists are very vulnerable especially in the dark winter nights, many residents use the Lane to walk to the Pub and church. Horse riders also often use this road again very narrow for a vehicle to pass a horse in sections.
- The Lane is unlit and very dangerous for pedestrians.
- Access to Woodmancote Lane from South Lane is at a give way but drivers often miss the 30mph signs and carry on at speed along this very narrow Lane.
- The 20mph should also be extended to beyond Varr Cottage to the West, again a very narrow section or even better all the way to Foxbury Lane if practicable.

South Lane, currently 40mph request to reduce to 30mph

- Reduce the speed to 30mph from the current 40mph, this Lane reduces from a wide new section of Road down to a narrow country Lane with no Footpath, pedestrians Cyclist and Equestrian users are very exposed and vulnerable to cars speeding along this section of Road, there is a wide verge between the old South Lane and the new Section of Road. This is often used by the residents to meet on and makes the 40mph section dangerous for any children gathering there. That section is also on a bend with limited visibility as well as a blind junction with Cemetery Lane, this needs to be reduced to 30mph. Cars still pass pedestrians walking in the highway at 40mph which is dangerous and an accident waiting to happen.
- The remainder of South Lane to Stein Road should be reduced to 40mph from the National speed limit. The reason being is that approaching Stein Road from Woodmancote the junction with Stein Road is almost blind, it has caused several accidents, although many not reported to the Police as they have been either minor or no injury. It is a dangerous approach to the junction, likewise in the opposite direction 40mph is more appropriate for approaching the built up area where we are requesting the 30mph speed limit.
- The Lane is unlit bar one light opposite Cemetery Lane, but unless you knw the Lane is there the junction is even more dangerous in the dark.

Old Farm Lane, Request reduction from National Speed limit to 40mph

- Old Farm Lane is quite wide from its junction with Stein Road toward Westbourne, however it narrows back to its original single lane in each direction at the bottom of the Hill, there are 2 properties at this point who find it very dangerous to enter a Lane where cars are doing 60mph, which they often do, some even try to overtake at this point to get past the car in front before reaching the narrow section, making it even worse for the occupiers to exit onto the Lane.
- The narrow section is in a poor state of repair and cars passing at speed are often pushed into the ditch at the side with built up embankments either side, if a Large Goods vehicle is approaching it makes it difficult to pass however, we have observed car divers sticking to their speed and very close to a head on collision for the sake of a few seconds. The 40mph would be a much more appropriate speed limit for this section of Road approaching the small service village of Westbourne and its 20mph speed limits, it makes a lot more sense to restrict Old Farm Lane to 40mph to the village gateway.
- Old Farm Lane is an Unlit road and is often used by Cyclists and Horse riders, there is also a dog walking business at the Gateway to the village which attracts a lot of vehicles changing every hour and sometimes every half hour, access from Westbourne means crossing the path of vehicles approaching the village.
- Pedestrians usually use the elevated footpath but this often becomes overgrown and unusable on those occasions the road is used by the pedestrians.

Whitechimney, southern section, Westbourne village, reduce from 30mph to 20mph

- There is a short section of Whitechimney which is 30mph from the village gateway to the 20mph approx. 70m, this should become the 20mph as you enter the village.
- The section of Road is the transition from Old Farm Lane into Whitechimney and is on a 90 degree bend, recent accidents have shown that vehicles approaching the village have not slowed down from the National Limits and ended up in the Flint wall straight in front of them, this has recently resulted in the footpath being closed whilst remedial work is carried out and as a result pedestrians have had to use the Road.
- Whilst the remedial work is taking place it has needed traffic Controlled lights for pedestrian safety.
- It makes sense to reduce this section to the existing 20mph beyond and makes a better transition into the village if Old Farm Lane is reduced to 40mph.

Consider reconfiguring of Stein Road, South Lane and Old Farm Lane.

- It might be beneficial to reconfigure the junction as above to make Old Farm Lane and Stein Road the through
 route as opposed to South Lane and Old Farm Lane. That way vehicles approaching the brow of the hill where
 Stein Road is would have to give way with a much clearer view along Old Farm Lane and Stein Road. Stein Road
 turning left into Old Farm Lane is the general path of traffic as is the opposite direction Old Farm Lane into Stein
 Road. This would reduce the issue of vehicles pulling out onto a 60 or 40mph road at slow speed when vehicles on
 the current through road are travelling at speed.
- South Lane should be made a give way entrance to Stein Road or Old Farm Lane.

Stein Road to Speed Limit heading South from Old farm Lane, reduce to 40mph

- If the above is considered appropriate then the speed limit along the section of Stein Road should be reduced to 40mph in line with Old Farm Lane and South Lane to the Gateway with Southbourne where the speed is likely to reduce to 20mph.
- A much safer transition from 40mph into a 20mph as opposed to the National Speed Limit.
- This section is in Southbourne Parish Area.

Parish / WSCC action

- Clare and Andrew Kerry-Bedell to monitor progress of the CHS W2
- Residents have been canvassed and generally support the proposals approx. 60 in favour 2 against out of 100 houses in Woodmancote

Parish / WSCC action

- Consider buying a new SID (solar type) for Westbourne Road
- AKB to contract Hants CC Lulu Bowerman re 20mph speed limit on Westbourne Road along to roundabout.
- New SID installed on New Brighton Road via Lulu Bowerman (also Hants CC Cabinet Member for highways)
- Make sure 20mph roundels are repainted regularly throughout Westbourne
- Monitor HGV movements after instilling new blue HGV signs on Foxbury Lane, Monks Hill and Aldsworth Road. Add new HGV sign opposite Park Road Southbourne
- Poor parking consider proactive A5 car window flyers and / or lock penalty notice stickers

Foxbury Lane TRO application (3810134) NSL to 40mph

This has passed the initial and detailed assessment, as well as the TRO moderation successfully, and is now with the WSCC legal team to undertake the public consultation which will run 20/02/2025 - 13/03/2025.

Whitechimney Row/Old Farm Lane (3822765) & Old Farm Lane/Woodmancote Lane (3099396)

Proposal is to reduce Whitechimney South end from 30mph to 20mph and Old Farm Lane from NSL to 40mph.


Despite failing the initial SPACE assessment, after conversation with WSCC Cabinet Member Joy Dennis and emails to Charlotte Weller at WSCC Highways both of these TROs are now progressing.

Monks Hill TRO (3822774) NSL to 40mph

Passed initial assessment, failed Detailed Assessment due to insufficient scoring in the SPACE assessment.

Other highways issues

- 1. Liaise directly with Southbourne Parish to put up HGV blue signs at exit of Park Road off Stein Road
- 2. Support Chidham in TRO for NSL to 30mph from West Ashling Road down to current boundary and 30mph past Cala Homes on Broad Road
- 3. TRO 3089548 / TRO W6 / CHS W12 The Square lining and parking combine into one CHS, apply July 2025

As part of our centenary year, during 2025 we will be running a series of exciting community events across our libraries. History of Southbourne Library

Like many libraries, Southbourne started out in the local school, where it stayed for 23 years. By 1929 there were 160 book readers and 3,300 books were issued.

The library moved into the church hall in 1948 and a children's section was established. By 1949 there were 770 book readers and 16,500 books were issued that year.

West Sussex based astronomer Sir Patrick Moore opened the new Southbourne Library in its new location on First Avenue on 3 July 1969, just days before astronaut Neil Armstrong took the first steps on the moon.



On display at the opening were a small astronomical telescope and space books written by Sir Patrick Moore, a Sussex resident, who joked that: "A lot of what is written about space... is a load of rubbish, and I should know because I've written much of it myself!"

Woodland Trust Nature Emergency Scorecard

Local Flood Risk Management Strategy consultation

WSCC is seeking your views in a public survey about its draft Local Flood Risk Management Strategy. Last September, we surveyed residents in West Sussex to ask about their experiences of flooding to better understand how the risks can be managed. All the comments and suggestions on flood risk management were used to develop our strategy. Now we're asking residents for their views on the draft before it goes to the next stage.

WSCC will continue to lead and support the development of the strategy under our nature environment pathway in our Climate Action and Adaption Plan. As the lead local flood authority for West Sussex, we're responsible for developing, maintaining, applying, and monitoring a Local Flood Risk Management Strategy. It will guide how we work with water companies, district and borough councils, residents, landowners and the Environment Agency to improve local flood risk management in the county, with specific actions for the next five years.

Flooding can have a devastating impact on our communities, businesses, infrastructure, and environment. The rapid pace of climate change means that the likelihood and severity of flooding is increasing. West Sussex is affected by multiple sources of flood risk, from rivers, watercourses and the sea, to surface and groundwater.

Despite many queries raised about increasing violent crime and ASB, with national police stats by area at odds with Sussex Police stats, the email below means it's good to know that all is Okay66 and crime is all now sorted in the Bourne area. Or at least according to your future potential 2026 Sussex Mayor, Katy Bourne...

I, for one, am not convinced Sussex Police are doing all they can from a neighbourhood policing perspective to tackle crime. Amongst others I will keep pushing hard for more community policing in Sussex with devolution.

Dear Councillor Kerry-Bedell, Thank you for your email of 17 February 2025 and for writing to Katy Bourne, Police and Crime Commissioner for Sussex.

We have been in touch with the District Commander and members of the Neighbourhood Policing Team who have responded to your concerns within previous correspondence. It is felt that the Bournes continue to be a safe place to live, work and visit with no alarming spike in crime or ASB. As such, there is nothing further that we can contribute at this time.

Parish contributions to the Bourne Bus

Beneficial changes to bus operation finances are being discussed with Parishes that involve changing the licence under which the bus operates, which will generate around £8,500 PA in bus pass rebates. This should bring the bus to within around £4,000 PA of break-even (excluding management charges) which is a substantial reduction and helps ensure the long-term security of this valuable transport for local residents.

Critical annual Parish contributions towards the running of the bus are due on 1st June 2025.

It would be useful if you could confirm you are willing to contribute the same amount as you did last year, and plan to vote on any contributions in advance of June, so we can budget accordingly.

Reducing Parish speeding through Speed Watch Groups and SID data

Stephen O'Connell at Sussex Police manages speed enforcement and 320 Speed Watch Groups (SWG) in Sussex, as well as helping support school speed initiatives and WSCC responses for requests for road speed reductions.

After a review with Steve regarding the four Westbourne SWG locations and SID data, he indicated that there are currently no SWGs for Chidham and Hambrook, Southbourne, Compton or Stoughton Parishes.

For Parishes interested Steve would be happy to talk them through the SWG requirements which only need 5 Parish volunteers + about an hour of training. He is running a SWG training and education session in April.

SWGs are invaluable in reducing Parish road speeds and they really do work in reducing speeds on local roads:

• 95% of motorists that get a letter from Sussex Police after being caught by an SWG do not reoffend in speeding anywhere in the Police South region in the following 12 months of their offence.

Other myths about speed watch groups

- Speed watch groups can also add abusive behaviour, dangerous driving, mobile phone use and lack of seatbelts via their body cameras and through the Operation Crackdown portal.
- Unlike speed cameras, SWGs do not need to have signs out saying they are operating on local roads

Steve also indicated that with Sussex Police having pulled out of the Sussex Safer Roads Partnership with WSCC and other Councils there would be initiatives to replace this which will be announced at the end of March.

In the last 12 months there has been failure of many speed reduction TRO applications mainly due to the lack of corroborating data held by Sussex Police. Parishes know that the lack of speed related incidents logged on the Sussex Police database is hardly surprising, given many speed related incidents occur at night, in bad weather, or due to other factors such as drink or drugs, where the owners do not want their vehicle to be logged.

With modern safer cars, there are also fewer injuries involved in these incidents, and WSCC has also said only one in 10 vehicle accident injuries makes it onto the Police KSI injury database to support a TRO application. So the result of these many speed related incidents is simply a vehicle insurance claim and the owners of walls, as well as Parishes and WSCC for the many village and other signs that get knocked down, having a repair bill.

Parishes appear to have been given the majority of burden of proof to get speed reductions enforced on their roads, and SID data is invaluable in this. Steve has a data analysis and accident triage team that meets regularly. They are happy to review all Parish SID data quarterly as a DAT or CSV file. This is invaluable, given the lack of road traffic police presence, and all data reported to Steve then goes onto the main Sussex Police database. SID data can then directly support future TRO and CHS applications for reduced speeds on all Parish roads.

Sussex Police is also trialling new technologies such as drones 1,000 foot up to catch the rear plates of speeding motorcyclists. They are also acquiring 6 new roadside speed vans, one of which was seen near the Travellers Joy.

Options to reduce speeds on Parish roads in general order of effectiveness:

- 1. Speed Watch Groups 95% effective in reducing road speeds in selected problem locations
- 2. SIDs (smiley / happy face) you can also send quarterly data to Sussex Police for analysis and logging
- 3. WSCC TRO or CHS applications to reduce speeds on a given stretch of road or residential area
- 4. Average road speed cameras (very effective as used on the A27 but £100k each)
- 5. Roadside speed vans (temporary only but only on main roads like the A259)
- 6. Speed cameras (£50k and, once their site is known by drivers, relatively ineffective)



ANYTOWN - Risk Assessment for Volunteer Litter Picking.

This form should be completed by the lead volunteer before the start of any litter pick. You will see that the points below are just common sense and are worth considering to ensure your event runs as smoothly and safely as possible.

As the organiser of the litter pick you should ensure that all volunteers know the risks and understand the control measures before clearing any litter. It is sensible to address all volunteers and introduce yourself as the lead volunteer/organiser, so they know who to go to with questions/to report an incident. You should also check that all volunteers know what equipment they must use and what area they may clean up. Also advise that a copy of the risk assessment is available on request.

Before starting your clean up ensure all volunteers:

- Have the correct Personal Protective Equipment (PPE) e.g. suitable gloves, hi-viz vest, sensible footwear, weather appropriate clothing etc.
- Have the correct equipment e.g. litter grabbers, plastic bags, dog waste bags, brush, shovel etc and know how to use the equipment.
- Consider all the risks and hazards in the work area, e.g. hazardous waste such as Asbestos, broken glass, dog waste, vomit, needles, condoms and roads/cycle ways, thorny bushes, low branches, uneven ground, hidden banks etc.
- Know the work area and how to report incidents or hazardous or unidentified waste, where to get first aid, meet on completion, deposit bags of waste and mark bags containing sharp material e.g. broken glass.
- If hazardous waste, or suspected hazardous waste, is found it must be left in-situ and must not be touched. Inform the District Council of the location of the waste for them to arrange for removal.

- All volunteers have reported back and all equipment is collected back in.
- All rubbish for collection has been left in the arranged pick up site.
- Any bags containing sharp material, eg broken glass, have been marked using the spray can.
